***Purchaser Agrees:***

*\*This kitten/cat is purchased for: PET*

*\*The deposit is non-refundable and will go towards the full price of the kitten/cat.*

*\*The buyer agrees and guarantees this kitten/cat will not be used for breeding purposes if not purchased for such.*

*\*To give proper space(NO CAGE), diet, fresh water, toys,exercise, and litter for this kitten/cat.*

*\*This kitten/cat is to only be an indoor pet. The purchaser agrees to only let the kitten outside when on a leash or in an enclosed space(catio) with close supervision.*

*\*Never is the kitten/cat be placed at an animal shelter, rescue center, research facility, nor will it be forsaken. The kitten/cat will not be sold to any pet store. The breeder will help to re-home the kitten/cat if it is necessary.*

*\*In the event the purchaser is unable or unwilling to own this kitten/cat any longer, the buyer shall surrender this kitten/cat back to the breeder for his/her own expenses.*

*\*If one of the family members develops an allergic reaction to the kitten, the kitten can be returned within a month granted that a doctor's note is provided. A refund would be issued, excluding deposit.*

*\*Under no circumstances will the kitten/cat be declawed. We consider this procedure inhuman and can harm the kitten/cat.*

*\*To register the kitten/cat to a veterinarian within 4 weeks of bringing the new family member home; to do the third FVRCP booster shot.*

*\*To neuter/spay the kitten within 8-10 months of age.*

*\*The purchaser is responsible for the kitten/cat transportation to their new home.*

*\*To pay for shipping expenses( air ticket and pet carrier).*

*\*To pay for a Health Certificate to travel.*

**Breeder Agrees:**

*\*The kitten/cat is sold in a good health condition, free of any contagious or harmful diseases at the time of sale.*

*\*To provide Vaccinations/deworming records and the Wellness Exam from a licensed veterinarian.*

*\*If purchased as a pet the registration papers (Breeder Slip) to register your kitten/cat with TICA will be provided only after proof from a licensed veterinarian is received. The purchaser shall provide the breeder a copy of the Neuter/Spay Certificate( Invoice).*

*\*The breeder warrants against any congenital malformation or genetic conditions that adversely affects the quality or length of the kitten's/cat's life within 12 months (Health warranty period) from the date of birth of the kitten/cat. If a kitten/cat is found to be showing signs of such congenital malformation within the health warranty period, the breeder will then replace the pet with one of equal quality when one is available. This warranty is only valid if Buyer(s) inform Seller of the condition within 2 weeks of diagnosis of a condition that falls under this warranty. This warranty covers both genetic and congenital causes except upper respiratory, FeLV, FIV and FIP (which are infections and may have an individual predisposition, and they are treatable). There is no refund of the purchase price. Shipping cost for replacement will be the responsibility of the buyer.*

*\*The breeder does not guarantee changes due to growth(definitive color of eyes, tooth displacement,allergies,etc.)*

*The breeder takes no guarantee for the disease FIP( Feline Infectious Peritonitis). The Corona-virus is part of 90% of the multi-cat households and breeding homes and mutation of the virus can happen without any responsibility of a human. The breeder of the cat cannot take any responsibility for this disease. Any compensatory damages are not possible and no replacement.*
