***This contract is between Mariana Haiseniuk owner of Kevin's Cattery,(hereafter referred to as Breeder/Seller), and Joel Wakefield, hereafter referred to as a Purchaser.***

***Purchaser Agrees:***

*\*This kitten/cat is purchased for: PET \_\_\_BREEDING\_\_\_.*

*\*The deposit is non-refundable and will go towards the full price of the kitten/cat.*

*\*The buyer agrees and guarantees this kitten/cat will not be used for breeding purposes if not purchased for such.*

*\*To give proper space(NO CAGE), diet, fresh water, exercise, and litter for this kitten/cat.*

*\*This kitten/cat is to only be an indoor pet. Purchaser agrees to only let the kitten outside when on a leash or in an enclosed space(catio) with close supervision.*

*\*Never is the kitten/cat be placed at an animal shelter, rescue center, research facility, nor will it be forsaken. The kitten/cat will not be sold to any pet store. Breeder will take the kitten/cat back and re-home if it is necessary.*

*\*In the event the purchaser is unable or unwilling to own this kitten/cat any longer, the buyer shall surrender this kitten/cat back to the breeder for his/her own expenses.*

*\*Under no circumstances will the kitten/cat be declawed. We consider this procedure inhuman and can harm the kitten/cat.*

*\*To register the kitten/cat to a veterinarian within 4 weeks of bringing the new family member home.*

*\*Purchaser is responsible for the kitten's/cat's transportation to their new home.*

*\*To pay for a Health Certificate to travel.*

*\*To neuter/spay the kitten within 6-8 month of age*

***Breeder Agrees:***

*\*The kitten/cat is sold in a good health condition, free of any contagious or harmful diseases at the time of sale.*

*\*That the Health Exam or Health Certificate(required for traveling) is from a licensed veterinarian.*

*\*If purchased as a pet the registration papers to register your kitten/cat with TICA will be provided only after proof from a licensed veterinarian is received. Purchaser shall provide Breeder a copy of the Neuter/Spay Certificate.*

*\*If purchased for breeding registration papers to register your kitten/cat with TICA will be provided.*

*\*Breeder warrants against any congenital malformation or genetic conditions that adversely affects the quality or length of the kitten/cat's life within 6 month (Health warranty period) following sale of the kitten/cat. If a kitten/cat is found to be showing signs of such congenital malformation within the health warranty period, the Breeder will then replace the pet with one of equal quality when one is available. This warranty is only valid if Buyer(s) inform Seller of the condition within 2 weeks of diagnosis of a condition that falls under this warranty. This warranty covers both genetic and congenital causes except FeLV, FIV and FIP (which are infections and may have an individual predisposition).*
